

Leadership

The DCF is a resource, a connector and a facilitator, nimble and ready to respond to community needs as they evolve. Over the past year, as our communities grappled with an ongoing global health crisis, social injustice and political unrest, we were moved to see Delawareans step up with record levels of generosity in response to the needs of their neighbors.

Building Opportunity

Through the **Delaware COVID-19 Strategic Response Fund**, a partnership of the Delaware Community Foundation and Philanthropy Delaware launched in March 2020, Delawareans donated more than \$5 million to address community needs related to the pandemic.

As of September 30, 2021, \$4,353,705 has been awarded through Community Needs Grants to more than 150 nonprofit organizations statewide, helping thousands of people throughout Delaware. Another \$689,520 from the COVID Fund was awarded through the Vision Grants Program, which also resulted in generous foundations and corporations investing more than \$2.6 million in these transformative initiatives for Delaware.

While continuing to address basic needs like food, housing and health care, the grant programs increasingly focused on education, childcare, the conversion of services to virtual platforms and the disparities in access to essential technology.

We are grateful for the continued partnership of our colleagues at the Delaware Alliance for Nonprofit Advancement and the United Way of Delaware.

Advancing Equity

The national spotlight on equity in the past two years has reinforced the importance of the work we began with our 2018 Building Opportunity initiative and have been expanding since. Our deepening commitment to equity has guided all of our work in the past year and will for years to come.

We are taking action. We are committing to the long-term institutional work we know is necessary. We are incorporating equity, diversity and inclusion at every step of our grantmaking process, and we will continue to help advance difficult conversations about systemic racism and how we collectively can drive real change.

In 2021, the DCF is advancing these conversations through a series of Book Circles and a keynote presentation by **Heather C. McGhee**, author of *The Sum of Us*, about how racism divides and



devastates us, and how we can chart a path forward together to create a just and equitable future for all.

DCF Journalism Internship Program

Four aspiring journalists worked in local newsrooms this summer through the new **DCF Journalism Internship Program**, Delaware's first statewide collaborative journalism initiative.

The program, funded by a grant from the Delaware COVID-19 Strategic Response Fund, increased news and information about the impact of the pandemic on BIPOC (Black, Indigenous, and People of Color) communities in Southern Delaware, strengthened the pipeline of aspiring BIPOC journalists, and advanced collaboration among local news outlets.

Grants & Scholarships

In fiscal year 2021, the DCF invested \$37,725,000 in the community, including \$608,524 from our **Community Impact Grants Program** and \$389,000 in **Scholarships**.

The DCF awards Community Impact Grants for programmatic and capital projects that improve quality of life in the First State and expand opportunities for all. This year's new **Leadership in Community Grants**, supported by a \$150,000 gift from Barclays, are helping build resilient, sustainable BIPOC-led organizations throughout Delaware.

Nuestras Raices provides arts and empowerment programs and initiatives that promote healthy living. They were awarded a \$25,000 Leadership in Community Grant to support their Emerging Leaders Development Program, a BIPOC-led initiative that helps future or growing leaders of color build experience and skills and adds to the talent pipeline for Delaware companies.

Delaware Technical Community College and the Delaware Skills Center have both received grants from the **Lentz Charitable Fund**, a DCF donor advised fund opened by Fred and Julia Lentz, who are committed to providing skills training opportunities for students interested in trades.



"I have been a long-time volunteer with Habitat for Humanity and have seen firsthand the need for skilled workers in the building trades," Fred Lentz said.

"My wife Julia and I partnered with the DCF because they enabled us to convert appreciated real estate and stock into funds that will support causes we care about forever. They worked with us to identify organizations providing trades training and provide easy one-stop shopping to distribute these donated assets to a variety of charities."

A Legacy Gift to Preserve African American Traditions

An anonymous donor recently came to the DCF with a passion to support African American cultural, economic and educational empowerment on the Delmarva Peninsula. With the DCF's help, the donor opened the **Heart to Heart Fund**, which will be funded with a planned gift at the end of the donor's life.

Among other organizations, the new fund will support Singing and Praying Bands (pictured), groups that practice a form of religious worship predating gospel, blues and jazz.

Partnership with the DCF made it possible for this donor to make a lasting philanthropic impact in perpetuity while also maintaining anonymity.

"The DCF is easy to work with and very cooperative. Although I'm by no means independently wealthy, this legacy fund makes it possible to benefit a wider community," this donor said. "I leave it up to the



DCF's professionalism to get the word out to various agencies that need funds for projects."

Since 1986, the DCF has been providing community leadership that benefits Delawareans throughout the state. Thanks to the generosity of our **Annual Leadership Campaign** donors, the DCF has been a powerful force for good for 35 years, serving as a facilitator, connector, cultivator and source of community knowledge.

Among this year's supporters of the Leadership Campaign are Lynne Howard and Don Brown, founders of the **Howard/Brown Family Fund** at the DCF. Earlier this year, they talked with us about what inspires their charitable giving and why they chose to partner with the DCF:

We were both raised in families that valued being engaged in community, educational, faith-based work and political action. Our parents modeled these values, and we were taught to give of our time, talents, and resources, however small, to make a positive difference in our communities.

Personal philanthropy, small and large, can help fill the gaps and complement the work and financing where government and other funding support is just not adequate to make a meaningful difference. In our own giving, we particularly look at organizations that serve the truly underserved sectors of our community and the diversity of our community, not just on paper but in reality.

Don's regular volunteer work with the DCF Scholarship and Grants committees also validates our joint view of the scope of need and provides a tangible view of the value of grantmaking in Delaware.




